Public Comment

Ron Furtick, 1500 Turbeville Road, stated he would like to present to council, mayor and citizens an update on Hickory Creek's future development. He recently met with several large commercial developers. The first developer, Centurion American, proposed a completely residential development of townhomes and apartments without any retail component whatsoever. Several other multifamily developers are also very interested in the location and multifamily projects are economically viable. The development of a mixed use walkable urban environment will require finding a developer who specializes in retail mixed use projects. Mr. Furtick met with Scott Polikov, who has a wealth of information and specializes in urban mixed-use development. Mr. Polikov agrees with Mr. Furtick that urban style development in suburban locations is the future of commercial development and identified three developers for introductions and preliminary discussions. Mr. Furtick wants to make sure opportunities are not lost because of issues in the past and current lack of general communication. Now is the time for everyone to pull together and move forward.
