The inspection fee will be two percent (2%) of the Certified Construction Costs of the land development for new subdivisions or any resubdivision. Inspection fees are to be paid half of estimated amount upon approval of Final Plat or Site Plan and the balance, based upon certified construction

costs, before work commences. 2%
