The meeting was called to order at 7:00 p.m. by Larry Crawford who also led the pledge. Councilman Theodore gave the invocation.

B. Public Hearing:

1. Public Hearing: To hear public opinion on a request from Jan Bowman for a variance of Chapter 14, Exhibit A, Article VIII SF-2 Residential District, Section 3 Area Regulations, (2) Side Yard to permit the construction of an accessory building in the required side yard on the property located at 718 Main Street, legally described as Hickory Acres Estates Phase II Block A Lot 4.

Jan Bowman, 718 Main Street, explained that the drainage from the neighboring homes runs through her property and, in order to not have to remove any trees, needs to build her accessory building closer to the property line. She has talked to her neighbors to explain the project and none of them have expressed any concern. She presented photos showing her property, the proposed location of the accessory and the water drainage. The structure will be 16 feet by 30 feet and used for storage of holiday items and garden equipment.

Angela Fiorelli, 718 Main Street, co-owner of the house, spoke in favor of the project.

Commissioner Crawford asked how far the building would be from the property line. Ms. Bowman responded 7 feet or about half of the required 15 feet. He also confirmed that there was a total of 2 acres on the property but that the rear acre was not accessible to building because of the trees. Commissioner Andrews asked about the foundation of the accessory and how it would be affected by the drainage. Ms. Bowman said she would be using pier and beam because a previous shed had to have a raised foundation with drainage underneath. Commissioner Armstrong clarified where the structure would be in relation to the drainage flow.
