- 1. Discuss, consider, and act on a site and landscape plan for RaceTrac, located at 4320 FM 2181, legally described as Hickory Creek Marketplace Addition, Block 1, Lot 1(pt), Town of Hickory Creek, Denton County, Texas.
- Ms. Chaudoir gave an overview of the project.

Commissioner Hawkes asked about the storm water question on page 3 of Halff Enginnering's comments. Travis Bousquet, Bousquet Group, explained it is a general requirement by the town with a scrape and rebuild project to insure the downstream run off is not increased. The calculations have been done and this project is reducing the concrete so there should be less run off.

Commissioner Holston asked if this is the same design as the others in the area. Andrew Malzer, RaceTrac, explained this is the new flagship prototype. There are a couple of others in the area similar to it. Commissioner Stefaniak asked if the radius comment from Halff had been addressed: it had.

Commissioner Hawkes asked about the 120 inches of removed trees not addressed on the landscape plan. Laura Hoffman, Winstead, stated they would be paying into the town's tree fund in compliance with the Subdivision Ordinance. Commissioner Hawkes asked Councilman Kenney if the town council would review the tree ordinance to increase the amount of the funds paid into tree mitigation fund.

Commissioner Barton felt the wording "side yard line" was not clear. After discussion and consultation with Mr. Berry, the wording was revised to "side yard setback line".

Motion by Commissioner Williams to recommend acceptance of the amendments to Chapter 14 with the discussed wording change. Seconded by Commissioner Barton.
